- · Penalty areas are marked with red and yellow stakes.
- · Repair all ball marks and rake sand bunkers. Leave rake in sand bunkers.

· White stakes define out-of-bounds.

- · Keep all carts 30 feet from greens, tees and sand bunkers.
- ALL PAR 3S ARE CART PATH ONLY, 90° rule is in effect on all Par 4s.
- · No fivesomes.
- · Each player must have own clubs.
- · Play is prohibited from areas marked as Environmentally Sensitive Areas (ESA). These areas are marked with a green topped red stake. Mandatory relief with a one stroke penalty, two club lengths, no nearer the hole.
- · The alternative to stroke and distance is in effect.
- Loose impediments may be removed from anywhere on the golf course.
